TOURNAMENT RULES

Eligibility:

- The tournament is open to current Genesee Region USBC members who have bowled at least 21 games in a league in the GRUSBC in the 2022-23 or 2023-24 season.
- Proof of membership in the GRUSBC will be required upon check-in.
- SMART approved; youth bowlers must sign waiver stating prize money will go to SMART.

Format

- All squads will have a maximum of 28 bowlers 7 per pair, using lanes 1-8. Bowlers will roll 4 games, drawing for their starting pair and moving each game per a pre-determined schedule as follows: 1-2, to 7-8 to 3-4 to 5-6; 3-4 to 1-2 to 5-6 to 7-8; 5-6 to 3-4 to 7-8 to 1-2; 7-8 to 5-6 to 1-2 to 3-4. One in 5 from each squad (4-game total) advance to the semifinals (rounding up). Semifinals consist of four games, per the schedule above.
- Upon completion of semifinals, the five bowlers with the top four-game semifinal totals pins from qualifying round WILL NOT carry over advance to the stepladder finals (the lanes will not be re-oiled before the stepladder finals).
- In the stepladder finals, the No. 5 semifinalist will face No. 4, with the winner facing No. 3, the winner facing No. 2, and the winner facing No. 1 for the title. All matches in the stepladder finals will consist of one game.
- 1 in 5 bowlers will cash. If a Senior (60-and-over) makes the cut outright, the 60-and-over incentive as stated on the front of this form WILL NO LONGER BE VALID.
- The high qualifier (four-game total) from all the qualifying rounds will receive a \$25 bonus.

Rules:

- All USBC rules will be in effect. Tournament director or committee decision is final.
- If two or more bowlers tie for the final spot in a qualifying round (four games), all bowlers will advance to the semifinals.
- If there is a tie for the Senior spot, it will be decided by a one-game roll-off.
- Ties in the stepladder final matches will be decided by an additional 10th frame.
- Any errors in scoring must be brought to the attention of the tournament director and corrected before the next competitor bowls.
- If mechanical problems, tourney director reserves the right to move bowlers to other lanes.

Re-entry:

Re-entry (\$55) is allowed as long as there are openings (as first-time bowlers have preference). A third re-entry (\$50) is allowed as long as there are openings (as first-time bowlers have preference).

Entry fee breakdown:

Prize fund: \$42 — Lineage: \$16 — Expenses: \$2 *Prize money will be paid by check within 10 days.*
